Chairman Beard stated at this time there would be a public hearing on the Fiscal Year 2024 Operating Budget and 2023 millage rate rollback for Gwinnett and Hall County property taxes. Chairman Beard opened the hearings with comments on the FY 2024 budget, the proposed tax increases for 2023 and gave an overview of the law and the City's proposed millage rate. The Commission is proposing a millage rate of 12.50 for 2023 for both Gwinnett and Hall Counties, Hall County with the LOST rollback. The property tax increase for Gwinnett County is proposed at 11.34% over the rollback millage rate of 11.227 and the property tax increase for Hall County is proposed at 26.08% over the rollback millage rate of 9.914. The public was given an opportunity to provide comments on the budget and millage rate rollback. Several inquired about the millage rate increases in Gwinnett and Hall Counties. The Chairman explaining the statute and homeowners with the Homestead Exemption will not see an increase in taxes. The audience did not have questions regarding the proposed Fiscal Year 2024 Operating Budget.

Allison Sinyard with Tunnel, Spangler, Walsh & Associates, gave a presentation regarding the City of Buford 2045 Comprehensive Plan Short-Term Work Program Five year update.

Chairman Beard stated that this concludes the public hearing portion of the meeting.

Property taxes bills are due December 20, 2023.
